### THE GIFT OF CYRILLIC – AREAL RNIDS

Areal RNIDS, a new Cyrillic typeface, produced with the support of the RNIDS Foundation in partnership with the Tipometar association, was presented on 28th January. The author of the fonts is lecturer of the Belgrade Faculty of Applied Art Olivera Stojadinović, and they can be downloaded free of charge from RNIDS' website.

Areal RNIDS is a gift from the Foundation to mark the anniversary of the .CPB domain, and was launched at a media event held in the House of Vuk's Foundation. The event included a presentation of the features

of the new typeface comprising four fonts, as well as more general discussion of the status and usage of the Cyrillic alphabet online. Speaking at the event was the author of the typeface, Faculty of Applied Arts lecturer Olivera Stojadinović, as well as assistant professors at the same faculty, Ana Prodanović and Olivera Batajić Sretenović.

The Areal RNIDS typeface drew considerable interest from the public and the media, and the download page on рнидс.срб was the most visited page on the website in Q1 2020.

## Upgrading the registrations system

### DNSSEC-PROTECTED .RS AND .CPB DOMAINS

Changes have been implemented in the domain name registration system that relate to accepting data for DNSSEC-signed domain names in all the domain spaces managed by RNIDS. DNSSEC-related domain data can be updated using a web application or the EPP interface.

DNSSEC allows the authenticity of the source from which the DNS response was received to be validated, as well as the integrity of the response itself. In practice this means that all those using DNS servers with active DNSSEC record validation can be safe in the knowledge that the DNS response for DNSSEC-signed domains has not been altered en route from the server to the user.

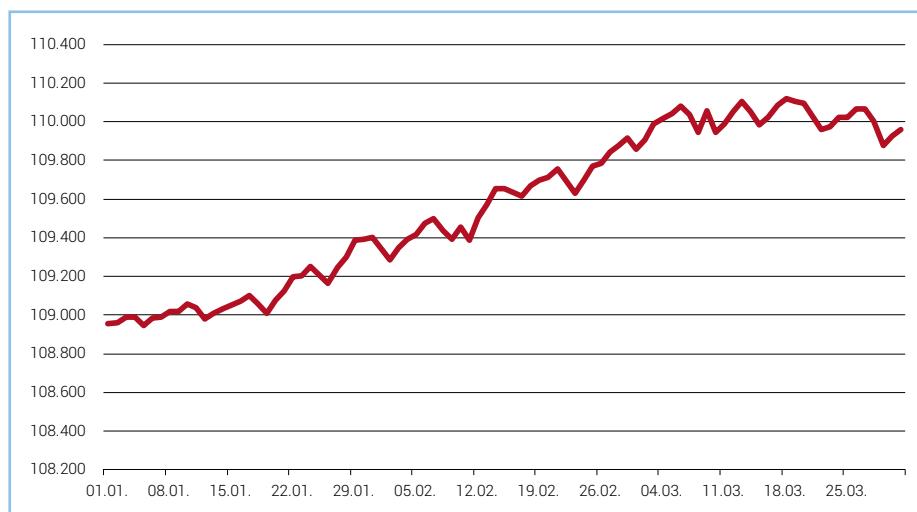

# DOMAIN STATISTICS

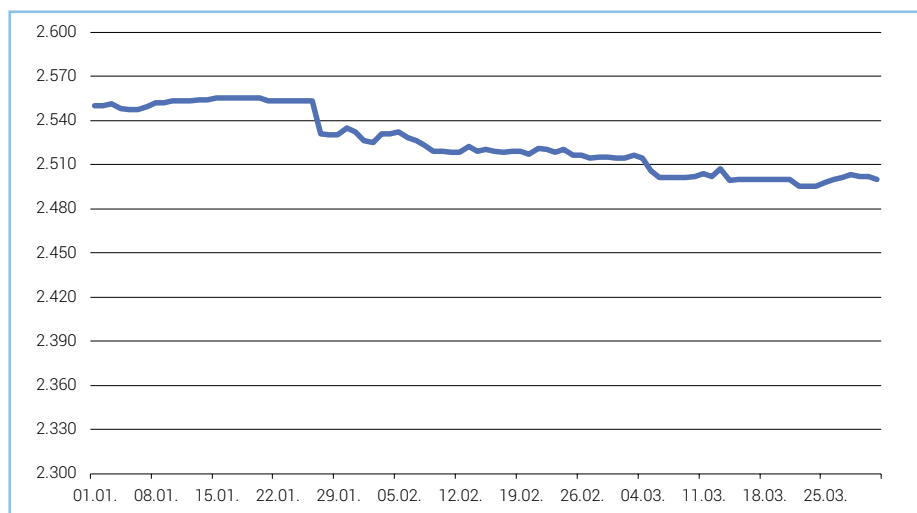
### Number of registered .RS domain names

# EDUCATION

The Pirot District Contracting Chamber of Economy and USAID's Cooperation for Growth Project organised a seminar in Pirot on 20th February on e-commerce, aiming to better acquaint businesspeople from the Pirot region with the opportunities for doing business online. 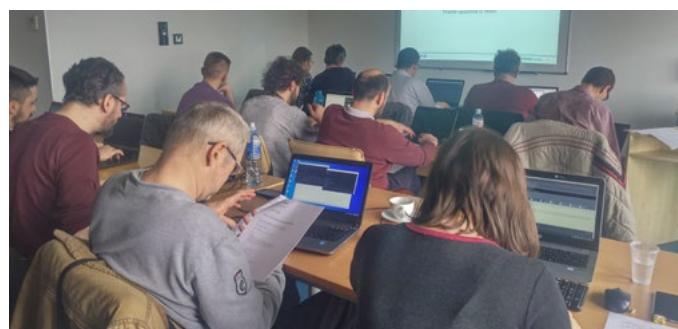

Two training workshops were held for accredited registrars prior to the introduction of the latest changes to the registrations system relating to the entry and verification of DNSSEC parameters.

The first workshop, held online, was on the basics of DNSSEC, the reasons to introduce it and why users of Serbian domains should use it, and how to enter DNSSEC parameters into the RNIDS domain name registration system. The workshop was intended for representatives of ARs working in domain administration and marketing. The second workshop, intended for DNS and systems administrators working at accredited registrars, was held on the premises of RNIDS. The all-day workshop addressed potential attacks on and abuses of the DNS system and the basics of DNSSEC, as well as providing tools and practical guidance on how to correctly DNSSEC-sign domain names.

# RNIDS ACTIVITIES IN EUROPE AND WORLDWIDE

## ICANN SSR: 16-17/1/2020, Washington (USA)

Žarko Kecić, Chief Technical Officer, took part in a meeting of the SSR2 team held 16th and 17th January 2020 in Washington, USA. The meeting was used to align positions on matters relating to the more active involvement of ICANN in the prevention of domain name abuse at the global level, as well as in activities to prevent future threats to the secure and stable functioning of the Internet at the global level.

## APTLD77: 18-21/2/2020, Melbourne (Australia)

The event was attended by the Chief Legal and Administrative Officer and acting director, who spoke at two panel discussions. During the discussion on IDN he shared RNIDS' experiences in the launch of registrations of .cpb domains and in adding characters in the .rs domain. During the legal session, which focused on suspension policies and mechanisms for the protection of third parties in general, he shared RNIDS' experiences and explained the mechanisms put in place.

## Activities in the CENTR community

## 61st CENTR Legal & Regulatory Workshop: 21-22/01/2020, Brussels (Belgium)

RNIDS' Chief Legal and Administrative Officer attended the workshop. In addition to the exchange of experiences amongst the legal departments of CENTR members, non-registry guests included a representative of Europol, who talked about the challenges they faced in investigating cyber-crime.

## 31st CENTR Marketing Workshop: 6-7/2/2020, Stockholm (Sweden)

RNIDS was represented by Predrag Milićević, Chief Marketing and Communications Officer, and Dijana Milutinović, Marketing and Communications Associate. The workshop was attended by representatives of 16 national registries, EUrlid, Afiliis and Verisign, who exchanged experiences and presented marketing campaigns that they had conducted.

## 63rd CENTR General Assembly/2020 Annual General Meeting: 12-13/2/2020, Ljubljana (Slovenia)

The meeting was an opportunity to share news and activities amongst member registries, and voting was also held for the Board of Directors. Board members elected were David Fowler – .CA, Philip Du Bois – .BE and Barbara Povše Golob – .SI, who was elected Chair of the Board. Additionally, the .KR (South Korea) registry was admitted as an associate member. The meeting was attended by Dejan Đukić.
